PruittCares Foundation Assumption of Risk and Release of Indemnity Agreement

In consideration of being allowed to participate in the 11th Annual PruittCares 5K Fun-Run/Walk, I acknowledge and agree as follows:

I know that participating or volunteering in a run/walk is a potentially hazardous activity. Some of the risks I may encounter include, but are not limited to: falls; contact with other participants; the effects of the weather, including heat stroke, heat exhaustion or dehydration; getting lost or separated; and being struck by vehicular traffic. **I agree to assume all inherent risks and all other risks, including those not specifically mentioned above.** I understand that I am responsible for ensuring that I am medically able and properly trained to complete the race or volunteer, but also agree to abide by any decision of a race official relative to my ability to safely complete the race.

I, for myself and anyone entitled to act on my behalf, waive and release the PruittCares Foundation and its subsidiaries and affiliates and all sponsors, agents, employees, officers, directors and volunteers working for PCF from all claims and liabilities of any kind, arising out of or related to my participation in the race and any other activities connected to the race. This release includes and prohibits all types of claims, including those for breach of contract, injury, loss, damage or death.

I understand that event photographs and/or video images will be taken on the day of the event. I freely give my permission for use of such photographs and video images in future PCF event promotions without further communication or compensation. I also agree that any dispute or suit I have will be resolved using the laws of the State of Georgia. Any mediation, suit or other proceeding must be filed or entered into only in Georgia.
